EXISTING COMPANY & USER/S LOGINS RENEWALS FOR SMART AUCTION SYSTEM FOR THE YEAR 2024 GUIDELINES

- 1. Company & User Registration Renewals for the year 2024 will be done through the e-Auction System. Please go through the User Manual and the Video Tutorials annexed.
- 2. Company Renewal
- (i) Update the Company information.
- (ii) Upload the required documents.
 - "Business Registration" A copy of the Business Registration issued by Registrar of Companies (ROC) or Local Government Authorities.
 - "Board Registration/Renewal (Tea Board issued for the current year)"
 - o Buyers/Exporters
 - Upload a copy of SLTB Registration for 2024.
 - Exporter cum Packers should upload both Exporter & Packer Registrations, and your Packer
 Registration 2024 should be uploaded to the "Other Document 1"
 - Producers
 - Copy of the Renewal of Registration as Registered Tea Manufacturer for the year 2024
 - Brokers
 - Copy of the SLTB Broker Renewal License issued for the year 2024.
 - "Company Declaration" Download the template. Upload the duly signed declaration with the company stamp.
 - "Proof of Payment" Payment of user/s renewals. Bank details are given below.
- 3. User Renewal
- (i) Upload the required documents for each existing user.
 - "<u>Declaration Form</u>" Download the Individual Declaration template. Upload the duly signed declaration with the company stamp.
 - "NIC" Copy of the NIC / Passport (bio-data page) of each user.

(ii) Special Note

- Amendments/updates to existing user/s details provided (mobile number, email etc.)
- Deactivation/s of Users
- Adding new users

Can only be done through the Office of the CTTA. Please notify your requirement to the Office of the CTTA by an email to info@ctta.lk.

- 4. Incomplete renewals without required documents as specified above and duly signed company and individual declarations, will not be approved by the Office of the CTTA.
- 5. Payments following charges will be applicable per user, per annum.

 - Non-Members Rs. 8,850/- (inclusive of 18% VAT)
