Colombo International Tea Convention **24th to 26th July 2024**

This newly rebranded convention aims to be the premier gathering for the global tea industry and is scheduled to take place from 24th to 26th, July 2024, at the Cinnamon Grand Hotel in Colombo, Sri Lanka.

The event will attract delegates from Europe, the UK, North America, Africa, Russia, the Middle East, India, Pakistan, Bangladesh, Vietnam, Singapore, China, Japan, and Australia. Attendees will include tea growers, manufacturers, marketers, exporters, retailers, buyers, suppliers, shippers, logistics providers, finance professionals, academics, NGOs and others from the value chain.
